Since 2009, the City of New York has implemented several laws and preedures with respect to construction projects and the safe abatement of Asbestos Containing Materials (ACM). On February 3, 2011, Chapter 1 of Title 15 of the Rules of the City of New York was released, which outlines the current asbestos rules and reuglations.

The New York City Department of Environmental Protection (NYCDEP) requires notification before any construction project can begin and the following phases must be completed (where applicable):

- 1. Pre-Abatement Activities
- 2. Notifying DEP of an Asbestos Abatement Project
- 3. Project Review
- 4. Conducting Abatement
- 5. Close-out

After the pre-abatement activities have been completed by a DEP-certified

To obtain a New York City Department of Buildings (DOB) Permit, an applicant must submit one of the following:

- ACP-5 Document: Asbestos Assessment Report
- ACP-21 Document: Asbestos Project Completion Document
- ACP-20 Document: Conditional Close Out Document

asbestos investigator, the project will be classifed as either a "Non-Ashestos Project" or an "Asbestos Project". In the event no asbestos was found, or the amount of ACM to be disturbed is less than 10 square feet or 25 linear feet, the project is classified as a "Non-Asbestos Project" or a minor project and the asbestos investigator may issue an ACP-5 document. A minor ACM project will still require abatement; however, filing paperwork with the DEP is not necessary. Alternatively, the discovery of any absestos greater than the aforementioned quanity, requires the completion of phases 2-5 before the project can begin.

If this process is not completed, and proper documentation submitted to the proper authorities, building owners can be subject to penalties of up to \$10,000 per infraction.

In addition to performing the investigation and providing the required documentation, Intertek-MT maintains a staff of certified New York State Department of Labor (NYSDOL) Asbestos Project Monitors capable of performing asbestos air technician services and project monitoring inspections during the asbestos abatement project on behalf of the owner and/or owner's representative.
